(iv) Other:

- The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (format attached).
- Those UG / PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the College to apply to the Central Council through Central Govt. and ensure that Permitted / Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

In view of above, I am directed to inform you that this is provisional affiliation to your college and as such you are requested to comply with the above mentioned deficiencies within the stipulated time without fail and submit compliance report. Compliance report will be verified by the University by re-inspection of your college.

Important Note:

- This Continuation / Extension of affiliation is issued for the A.Y. 2022-2023 subject to the permission of NCISM / Govt. of India / Department of AYUSH, New Delhi and if the permission is declined by the said authorities, this Continuation / Extension of Affiliation will be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCISM / Govt. of India/ Department of AYUSH New Delhi.
- The admission shall be done through the Competent Authorities only.
